WHAT ARE COOKIES?

Cookies are small text strings that the visited website or third parties place and store on the user's device (be it a PC, smartphone, tablet, IoT device, ...). The browser with which you are browsing can store cookies and transmit them again to the site that generated them on the occasion of a subsequent visit, thus maintaining memory of the previous interaction. The information encoded in the cookies may include personal data, such as IP address, username, unique identifier or e-mail address, but may also contain non-personal data, such as language settings or information on the type of device used.

Cookies can be divided into three macro-categories based on the purpose:

- **Technical cookies.** Technical cookies are necessary for the website to function properly and to allow navigation; without them some pages may not be displayed correctly or it may be impossible to use some services of the site. For example, a technical cookie is essential to keep the user connected throughout the visit to a website (so-called navigation or session cookies), or to memorize the language settings, the display, and so on. The installation of these cookies is automatic upon accessing the website and the user's consent is NOT required for this to happen.
- **Analytical cookies.** Analytical cookies are used to evaluate the effectiveness of the website or to help measure its "traffic", that is, the number of visitors broken down by geographical area, connection time or

other characteristics. User consent is NOT required for first-party or third-party anonymized analytical cookies.

- **Profiling cookies.** Profiling cookies are used in order to send advertising messages in line with the preferences expressed by the user while browsing and can only be used with prior consent. This site does not use profiling cookies.

We can also divide cookies according to the subjects involved in:

- **Direct or first party cookies.** These are cookies sent directly by the operator of the site the user is visiting.
- **Third party cookies.** These are cookies installed by a different site through the first.
